8. To prepare special reports on fiscal issues as they arise and at the request of members of the Senate.

OVERVIEW

The information in this document is based on reports filed by State departments and agencies pursuant to Section 396(3) of the Management and Budget Act (Public Act 431 of 1984), which is included in [Appendix A](#). Based on the amounts reported, the State of Michigan paid \$82.3 million for judgments and settlements in fiscal year (FY) 2018-19. Of the 104 cases that resulted in payments, 26 were judgments totaling \$6.0 million, and 78 were settlements totaling \$76.3 million.¹

Payments in FY 2018-19 were \$26.2 million (46.8%) higher than the \$56.0 million reported in FY 2017-18. The department with the largest variation in payments from FY 2017-18 to FY 2018-19 was the Department of Treasury, in which payments were made for various tax settlements and wrongful imprisonment claims.

Tables on pages 2, 3, and 4 provide a 10-year history (FY 2009-10 through FY 2018-19) of payments made by the State of Michigan. [Table 1](#) provides information on total payments (judgments and settlements), [Table 2](#) lists payments resulting from judgments only, and [Table 3](#) lists settlements. [Table 4](#) and the following narrative provide a summary of departments with payments totaling over \$1.0 million. [Table 5](#) on page 7 provides a history of highway negligence payments from FY 1983-84 through FY 2018-19. [Table 6](#) on page 8 includes a history of payments from the State's Risk Management Fund for automotive liability. Payments from the Fund historically have not been included in amounts reported by departments. Also, small claims approved by the State Administrative Board are not included in this report. [Table 7](#) and the information on pages 9 and 10 provide an overview of cases that resulted in payments to the State.

The FY 2018-19 reports submitted by State departments and agencies on payments made by the State follow in [Appendix B](#), beginning on page 12. For each payment, the name of the case is listed along with information regarding the funding source, the county where the cause of action arose, and a brief description of the cause of action (summary of case). This report does not include payments resulting from workers' compensation or unemployment claims.

¹ The number of cases does not reflect the actual total number of cases. The Department of Treasury did not provide detail on various tax-related cases because of confidentiality requirements under Michigan Compiled Laws (MCL) 205.28(1)(f).

PAYMENTS BY DEPARTMENTS

In FY 2018-19, three State departments made payments totaling more than \$1.0 million. Table 4 and the following narrative summarize these payments.

Corrections

The Department of Corrections made payments in 65 cases totaling \$4.8 million in FY 2018-19, an increase of 32 cases and \$1.1 million in total payments from the previous fiscal year. Payments ranged from a \$25 mediation award paid to an inmate for staff retaliation to a \$1.3 million settlement that included remedial actions to be taken by the Department to cure alleged violations of the Americans with Disabilities Act and the Federal Rehabilitation Act due to a lack of accommodations for hard-of-hearing prisoners in custody. Five cases with settlement payments over \$250,000 each accounted for roughly \$4.0 million (82.0%) of the payments made by the Department of Corrections in FY 2018-19.

Transportation

The Department of Transportation (MDOT) made three settlement payments for nearly \$4.2 million. Two settlements for claims filed under the Elliott-Larsen Civil Rights Act totaled \$2.8 million, and a third claim from a construction company settled for \$1.4 million of additional compensation for extra work performed under contract.

Treasury

The Department of Treasury made payments totaling \$71.4 million in FY 2018-19, up from \$43.3 million from the previous fiscal year. Settlements designated as "Various for Tax Related Cases" accounted for \$65.5 million (91.7%) of FY 2018-19 payments made by the Department. Details on these cases are not provided because of MCL 205.28(1)(f). That section of the law provides, in part:

Except as otherwise provided in this subdivision, in subsection (6) or (7), or in section 23a, an employee, authorized representative, or former employee or authorized representative of the department or anyone connected with the department shall not divulge any facts or information obtained in connection with the administration of a tax or information or parameters that would enable a person to ascertain the audit selection or processing criteria of the department for a tax administered by the department.

Nine judgments under the Wrongful Imprisonment Compensation Act totaled \$5.9 million in FY 2018-19, a substantial increase from the previous fiscal year, which had three judgments for a total of \$2.3 million in payments.

Highway Negligence Cases

From FY 1983-84 through FY 2018-19, the State paid \$237.2 million resulting from 1,178 highway negligence cases. Since FY 1999-2000, total payments and the number of cases resulting from highway negligence litigation have declined dramatically. In FY 2013-14, no payments resulted from defective highway claims. There was one payment of \$5,500 in FY 2014-15 and two cases with payments totaling \$73,000 in FY 2015-16. In FY 2016-17, there was a payment of \$4,500 for one case involving an alleged defect (pothole) in a crosswalk on M-37 resulting in an injury to plaintiff's ankle. In FY 2017-18, there was one settlement of \$325,000 for injuries sustained by a motorcyclist when he hit a sinkhole in Highland Park. There were no judgments or settlements paid by MDOT for highway negligence in FY 2018-19.

Of the total amount paid for highway negligence cases since FY 1983-84, \$225.4 million (95.2%) was paid before FY 2000-01. The reduction in payments is attributed to statutory changes and rulings by the Michigan Supreme Court that limited the State's exposure to liability. Table 5 provides a history of highway negligence payments by fiscal year from FY 1983-84 through FY 2018-19.

RISK MANAGEMENT FUND

The Risk Management Fund was established administratively to account for specific centralized risk management functions performed for all State agencies by the Department of Management and Budget (now the Department of Technology, Management, and Budget). Effective July 1, 1992, the State became self-insured for automotive liability claims. Motor transport charges to State departments and agencies include a cost associated with projected automotive liability. This amount is deposited in the State's Risk Management Fund. Automotive liability payments that do not exceed \$1.0 million are paid from the Fund. Table 6 provides a history of payments from the Fund. Amounts are reported based on the fiscal year in which the payment was made and, therefore, do not necessarily reflect the year in which the liability occurred.

Attorney General

The amount reported by the Department of Attorney General, \$290.7 million, resulted from an annual payment from a single case, the Master Tobacco Settlement Agreement. The 1998 settlement resolved public health-related claims filed by Michigan and other states against the nation's major tobacco companies.

Corrections

All of the payments listed by the Department of Corrections resulted from cases filed under the State Correctional Facility Reimbursement Act. The Department reported 276 cases with net payments to the State totaling \$3.3 million. Payments to the State ranged from \$15 to \$181,300. All but three cases resulted in a payment to the State of less than \$100,000, with an average payment of \$11,916.88.

Environment, Great Lakes, & Energy

The \$5.1 million recovered by the Department of Environmental Quality (DEQ) in FY 2018-19 mainly involved reimbursement for environmental contamination and other violations of the Natural Resources and Environmental Protection Act. Recoveries in those cases were deposited into various funds (e.g., Environmental Response Fund, Environmental Pollution Protection Fund, and General Settlement Fund). Settlement revenue is restricted by legal agreements or court orders for specific environmental cleanup activities at specific sites of environmental contamination or restricted to other environmental programs as appropriated. Of the 217 cases reported by the DEQ, 42 were judgments totaling \$1.0 million, and 175 were settlements or the result of other agreements totaling \$4.1 million.

The largest payment reported was \$886,814.73, a settlement with Enbridge, Inc., for an oil spill into the Kalamazoo River in 2010. The fine reported by EGLE is unrelated to a \$62.0 million civil penalty Enbridge agreed to with the Federal government in 2016.

Natural Resources

The Department of Natural Resources (DNR) reported three cases with payments to the State totaling nearly \$350,000. Payments to the DNR ranged from a \$50 judgment for a case involving restitution for damage to the Oden State Fish Hatchery viewing chamber, to \$248,144.76 in *MDNR v. Consumers Energy*. The *Consumers* case is a multiyear settlement that began in 1995 and will continue through 2035. The FY 2017-18 payment was \$477,208. The Fisheries Settlement Fund was established to receive payments by Consumers. Settlement funds are earmarked and used for habitat mitigation work in the area or watershed where the violation occurred. Since 1995, payments by Consumers have totaled \$14.5 million.

Transportation

Payments to MDOT totaled \$2.6 million from 38 settlements and 6 judgments. One of the judgments was for \$7,200 in nonpayment of permits dating back to 2010. All but two payments totaling less than \$8,000 were the result of damage to MDOT's trunkline system and were paid into the MDOT's State Trunkline Fund. The three largest settlements all involved damage to MDOT bridges, including \$593,708.60 for damage to the Pleasant Valley Road Bridge on eastbound I-96 near Brighton, \$396,497.07 for damage to the South Street Bridge on southbound US-127 near Mason, and \$346,852.01 for damage to the overpass on 6 Mile Road in Kent County.

Treasury

The Department of Treasury reported payments of \$290.7 million related to the Master Tobacco Settlement Agreement with the tobacco companies; however, that amount is listed in this report under the State's Attorney General's Office. The remaining \$15,450,921.52 reported by Treasury come from various tax-related judgments and settlements, the details of which are not disclosed pursuant to MCL 205.28(1)(f).

CONCLUSION

This report provides a summary and analysis of information supplied by State departments pursuant to Section 396 of the Management and Budget Act (Public Act 431 of 1984), which is included as Appendix A. Reports submitted by State departments and agencies on payments made by the State are included in Appendix B. For each payment, the name of the case is listed along with information regarding the funding source, the county where the cause of action arose, and a brief description of the cause of action (summary of case). Further information on specific cases is the province of the defendant department and the Department of Attorney General.

APPENDIX A

Section 396 of the Management and Budget Act (1984 PA 431)

18.1396 Paying or recording certain expenditures from appropriations; notice of certain settlements or consent judgments; report.

Sec. 396. (1) From the appropriations contained in a budget act, a state agency shall pay or record expenditures for the following:

- (a) Court judgments, including court approved consent judgments; all settlements, awards, and claims.
- (b) Writeoffs of accounts receivable recorded in a prior year.

(2) The attorney general shall notify the senate and house appropriations committees, the speaker of the house, the senate majority leader, and the fiscal agencies within 14 days after entering into a settlement or consent judgment which would result in a state obligation that exceeds \$200,000.00. The notice shall include a summary of the facts of the case and the reason or reasons that the settlement or consent judgment would be in the best interests of the state.

(3) Before December 1 of each year, each principal department shall transmit to the appropriations committees and fiscal agencies a written report which includes all of the following:

- (a) The total dollar amount of final judgments and settlements against the principal department for the most recent completed fiscal year.
- (b) Each source of funding and item appropriating money in a budget act, which source and item is used to pay the judgments and settlements pursuant to subdivision (a).
- (c) The total dollar amount of final judgments and settlements received in the most recent completed fiscal year pursuant to legal actions by the principal department.
- (d) Each revenue account in which money was credited pursuant to subdivision (c).
- (e) An estimate of the total dollar amount and a description of the facts involved in each court action currently pending against the department for the most recently completed fiscal year.
